

# Agreement for the care of a pet

The agreement is concluded between the guardian of the animals, the company Kocie Porady Eichelberger Mieszko with its registered office at ul. Tadeusza Rejtana 1b / 2 80-050 in Gdańsk; the company represented by Mieszko Eichelberger, hereinafter referred to as the Guardian / Coordinator, and the Legal Guardian of the animal, hereinafter referred to as the Owner.

The owner declares that the animal / animals is / are his / her property and at the time of transferring him / her to the Care, he / she has the full right to put the animal / s under the Care; in addition, it has a valid health booklet and informs that the animal:

- is healthy - .....
- is ill - .....
- requires the following treatments - .....
- the cat has valid vaccinations - .....
- is dewormed - .....
- is a carrier of an infectious disease - .....

The owner is aware that any change in the environment of the animals, or e.g. lack of contact with the guardian may (but does not have to) be associated with stress, which may be shown by the animal during the shift (e.g. during the owner's departure), but also after its return home. Peri and post-stress behaviors include, among others: excessive sleepiness or agitation, lack or increase in appetite, temporary disturbances in the daily rituals and habits of the animal, temporary loss of immunity. Petsitter / Guardian makes every effort to reduce the resulting stress; it also provides advice on how to help your pet survive the separation from its owner. It is worth informing the Caregiver in advance that the pet is strongly attached - the Caregiver will advise what exercises to introduce so that the time of separation is not so troublesome for the animal.

The owner declares that the veterinarian responsible for the animal is the attending physician in the office (name, address, attending physician) -

The Owner authorizes the Guardian to use the services of the attending veterinarian indicated by the Owner when the animal shows signs of disease. In emergency situations, the Guardian has the right to choose a veterinarian to whom the animal will be transported. The Guardian can deliver by his own car or other means of transport (the best in a given situation, according to the Guardian's opinion).

The Guardian undertakes to inform the Owner about this as soon as possible.

The owner undertakes to cover the costs of veterinary treatment of his pet (including the costs of transport to the veterinarian), which were incurred by the caretaker, and not due to his fault, within 3 working days from the end of the ordered care.

The owner undertakes to cover the cost of caring for the animal.

In connection with the conclusion of this contract, the Guardian undertakes to:

- perform the ordered activities of caring for the animal (feeding, watering, cleaning the litter box, play, walk (in the case of a dog or a cat wearing a harness) with special care, according to their best knowledge and skills; the rhythm / time range of care is set out in the first paragraph;
- taking personal care of the animal / animals during their physical presence in the house / apartment ( care is ad hoc, of which the Owner is aware);
- follow all suggestions and specific recommendations of the Owner -

- ensuring the ward's safety, the right amount of meals and the right dose of exercise
- to be transferred a The owner of periodic information about the entrusted animal - in accordance
- with joint arrangements (e-mail contact, text message of the Caregiver with the Owner + photos)
- for immediate telephone contact with the owner of the animal in emergency situations (illness, injury, missing animal), telephone -... ..

- taking care of the physical and mental condition of the entrusted animal, and if necessary - provide him with veterinary care, immediately notifying the owner of the animal about this fact,
- not entrusting the activities ordered in the contract to third parties without prior arrangement with the Owner; persons who are accepted by the Owner to help the Guardian are co-workers of the project and is / are (name, surname, ID card number) -

whose actions are considered to be the actions of the Guardian and are subject to this agreement.

The guardian is not responsible for the disease and death of the animal which is not his fault.

The date of care for the animal specified in this contract may be- with the consent of the Guardian changed and the Owner. During the care, the parties are in contact by phone and / or e-mail, during which changes in the scope of care may be agreed; conversation and arrangements by phone or e-mail are treated as a binding agreement between the parties.

In the event of shortening the period of care, the amount paid in advance is not refundable.

In the case of extending the period of caring for the animal - with the consent of the Guardian - the Owner is obliged to pay the amount within 3 working days after the end of the ordered care.

The owner is aware of the fact that he entrusts the keys to his apartment / house for specified the time in the Agreement. The dates and method of handing over the keys to the Guardian and after the care period to the Owner are agreed by the parties as follows: the

- keys will be thrown into the box or under the doormat, the
- keys will be picked up from the guardian "in the city", the
- keys will be delivered to the customer's home, free of charge, but the time to do up to 14 days from the end of care,

In the event of random events, due to which it is impossible to collect the keys to the house (apartment), taking over the care of the animal, arrangements by phone or e-mail between the Parties to this agreement will apply.

In the case of random events, as a result of which it is impossible to collect the keys to the house / apartment and take over the care of the animal by the Owner at a predetermined date, the Guardian is obliged to contact the person indicated by the Owner / agreed jointly by the Owner and Guardian.

This person becomes the Owner's Representative and it is: .....  
 ..... (name, surname, ID number) and give him / her the keys and entrust the responsibility for the animal. The Guardian is not responsible for the actions of the above-mentioned person while caring for the animals.

The guardian of the animal is not responsible for any random events not due to his fault, which could occur in the Owner's house / apartment during the service period (established under this contract or after newer telephone or e-mail arrangements referred to in the contract).

The Owner is aware that the Caregiver provides temporary / periodic care for the animal / animals, as set out in the first paragraph of this contract, and is not staying at the animal's location for the entire duration of the Owner's absence. The guardian is not responsible for random events or any other events that took place during his absence from the place where the animals were located.

This contract has been drawn up in two identical copies, one for each party.

In matters not covered by this contract, the provisions of the Civil Code shall apply.
